Yellow Fever Vaccine Provider/Center Application

I hereby apply to the Florida Department of Health Immunization Section to be designated as a Yellow Fever Vaccine Provider/Center and I agree to the following control measures and requirements.

1. The yellow fever vaccine is a multi-dose vial vaccine and must be stored at temperatures of 2°C–8°C (35°F–46°F) until it is reconstituted by the addition of diluent supplied by the manufacturer. It is required that refrigerator temperatures be checked and documented each morning and each afternoon. The diluent may be stored in the refrigerator with the vaccine or separately at room temperature.
2. Once the vaccine has been administered, traveler and vaccine dose information must be entered in the Florida SHOTS centralized online immunization registry within seven days of administration. You may visit flshots.com/ for more information.
3. The vaccine must be promptly administered; any unused vaccine should be discarded within one hour of reconstitution. Reconstituted yellow fever vaccines must be kept on ice once reconstituted and used within the provided time.
4. The Yellow Fever Uniform Stamp must be properly safeguarded and access to it must be limited only to the official signing this application and his/her formally designated (in writing) representatives.
5. Notify the Florida Department of Health Immunization Section immediately if the stamp holder's address changes, if the stamp holder is no longer providing this service, or if the stamp is lost or stolen. Submit the Change of Address Form found here: FloridaHealth.gov/programs-and-services/immunization/yellow-fever-vaccine-provider/index.html.
6. Reports of any serious vaccine adverse events must be made promptly in the Vaccine Adverse Events Reporting System (VAERS). Serious adverse events are those that require a health care visit within 30 days of the vaccination.
7. A list of countries and areas in which yellow fever is endemic shall be maintained and kept current at each center. This information is included on the CDC yellow fever website and can be found at cdc.gov/yellowfever/maps/index.html. Travel health notices are posted to CDC Travelers' Health website at wwwnc.cdc.gov/travel/.
